### **VOLUNTARY ANNOUNCEMENT INCREASE IN SHAREHOLDING BY CONTROLLING SHAREHOLDER**

This is a voluntary announcement made by E-Rental Car Company Limited (“**Company**”) to inform its shareholders and potential investors of the latest information regarding its controlling shareholder.

The Company was informed that Sino Merchant Car Rental Limited (“**Sino Merchant**”) acquired 22,980,000 ordinary shares of the Company (the “**Purchase**”) on the market today.

Sino Merchant is owned as to 60% by Ms. Deng Shufen (“**Ms. Deng**”), 20% by Ms. Liu Jianguan and 20% by Mr. Gui Bin, all three being executive directors of the Company. Ms. Deng is deemed, or taken to be, interested in all of the ordinary shares in which Sino Merchant is interested by virtue of Part XV of the Securities and Futures Ordinance, Chapter 571 of the Laws of Hong Kong (“**SFO**”). Immediately prior to the Purchase, Sino Merchant was interested in 3,416,253,889 ordinary shares of the Company, representing approximately 52.71% of the total issued share capital of the Company. Immediately after the Purchase, Sino Merchant has become interested in 3,439,233,889 ordinary shares, representing approximately 53.06% of the total issued share capital of the Company as at the date of this announcement.
